

GOVERNANCE COMMITTEE UPDATE

Following the approval of the amendments to the OAAS constitution at the 2016 Annual General Meeting, your District Directors have begun the next steps in



accomplishing the two year work plan set by the OAAS Board in 2015.

At their Spring meetings, Directors and members societies discussed how the necessary changes would be made to update district policies and allow for the election of a Provincial Director at the Fall Annual General Meeting. In some cases, ad hoc committees have been struck to accomplish this task, in other cases, the District Executive will be responsible.

All of the draft district policies will be reviewed in July by the OAAS Executive and the Governance Committee and then returned to the Districts to be finalized and circulated to their members by September.

At the same time, the Governance Committee, with the assistance of the Office Manager, Vince Brennan and Rob Black, Rural Ontario Institute are reviewing the current policies and procedures of the Association. All of this review and updating is meant to clearly define the roles and responsibilities of all involved and prepare for the upcoming changes in Board structure and size.

Registering is Easy and Free

Ontario Provincial Premises Registry: Registering is Easy and Free

Accurate premises verification and identification is critical to the strength of Ontario's agriculture and food sectors. Being able to trace your products as they move through the supply chain on their way to the customer is beneficial because it can protect your reputation in a food safety incident and open new market opportunities.

Established in 2008, the Provincial Premises Registry (PPR) registers unique parcels of land in Ontario associated with agri-food activities. Registering is completely voluntary, and provides the following benefits:

- Premises identification can strengthen your business by improving your market advantage and protecting your brand. It's what retailers are demanding from their suppliers.
- An accurate premises registry enables the Ontario government to swiftly respond to incidents that could financially harm agri-food businesses, such as weather-related disasters, animal or plant disease outbreaks or contaminated food incidents.
- Registering with the PPR is the only way to obtain a Premises Identification Number (PID) in Ontario.
 Possession of a PID also qualifies you to participate in various agricultural programs.

How to Register

Registering your premises is quick, easy and free. Simply fill out the online application form at www.ontarioppr.ca or call Angus GeoSolutions Inc. (AGSI is the official Registrar of the Ontario PPR), at 1-855-697-7743 to register in English or French.

You will be asked to describe the agricultural or agri-food activities that occur on your premises, to provide emergency contact information for your business and to accept the PPR consent statement. You will need to have

your Assessment Roll Number - your tax assessment number from the Municipal Property Assessment Corporation (MPAC) handy, or if not, you will need to provide one of the following:

- Latitude and longitude coordinates from a global positioning system
- Legal land description (lot, concession number and township of the premises)
- Municipal address of the premises to be registered

If you decide to register online

- Visit www.ontarioppr.ca and click on "Register Now".
- Enter your contact information. Enter your premises information and indicate the activities occurring on the premises.
- You will be asked to read and accept the PPR consent statement.
- When you have completed the information categories related to the premises, you have the option to exit, to register a sub-premises (see article #3 in this series for more information) or register another Premises ID.

Once your premises information has been validated by AGSI, your premises will be assigned a unique Premises Identification Number. A PPR certificate will be mailed or e-mailed to you. Most certificates are sent out within two business days of receiving your updated information. You may be contacted if any discrepancies or questions arise.

While voluntary, participation in the PPR can benefit your business' bottom line and it is quick and easy to do. Go online or call today to get started.

Liquor Liability

Loss Prevention Bulletins

Does your Agricultural Society serve alcohol? If so, the increasing risk of liquor liability is a real potential. While this topic does extend beyond commercial operations into social and employer related function, the scope of this information is to assist in the effective management of risk. Training and preventive measures can be beneficial in reducing the potential for a loss.

Considering that a liquor liability claim can be made long after the actual event, the case can become difficult if adequate records have not been kept, witnesses and personnel are no longer around, and if the individual involved has been killed or seriously injured.

The following tips and suggestions are provided to assist in reducing the potential of a loss:

- Do your servers have training in any intervention programs in serving alcohol? There are various programs initiated through your provincial hospitality associations.
- Do you have a written or verbal policy and procedures program in effect, and is it being followed?
- What are your policy and procedures for serving suspected intoxicated patrons?
- Does your policy include sections dealing with: excessive consumption, refusal to serve if intoxication is suspected, ensuring designated drivers do not drink alcohol, and offering to pay for taxi, hotel rooms, or car service?
- Procedures to record incidents a written incident log/report is encouraged to record any and all incidents of intoxication, eviction or injuries
- Contacting police if situation warrants intervention
- Is entry denied to persons who appear intoxicated?
- Does staff habitually check patrons to ensure they are of legal drinking age, asking for approved identification?
- Do you offer or suggest an alternative mode of transportation to intoxicated patrons? Is a telephone number for a taxi service posted and a phone available?
- Do servers inquire within groups if a designated driver has been chosen, and are non-alcoholic beverages supplied to that individual?
- Is your staff allowed to consume alcoholic while serving or at work?
- Is communication maintained between all staff if a patron is suspected of consuming too much?
- Can your staff effectively identify potential characteristics of an intoxicated person, such as being overly friendly, slow response time, argumentative or belligerent, talking loudly and/or obscene language, making sexual advances, bumping into others, spilling drinks, physical appearances (glazed look), repeating jokes or stories, being careless with money?

With our changing legal environment, licensed establishments must exercise good management practices and strive for loss prevention measures and considerations to reduce the potential of a tragic loss - often resulting in death and/or serious - personal injuries.
