Registration:

You must register in advance for this meeting by clicking on the following link: https://zoom.us/meeting/register/u5luf--vpj4rCO7XJCv0a_NmNv-LtPvoCg

You may register at any time but we suggest registering at least several hours prior to the call due to the large number of participants.

You will be asked to input your name and email address – <u>please verify your email</u> <u>address is correct</u>. After registering, you will receive a confirmation email containing information about joining the webinar either by your computer or phone.

NOTE: If you don't receive a confirmation email – please contact me – we ran into a couple instances where the email was entered incorrectly so they didn't receive the registration email.

Accessing the call:

We will be using Zoom video conferencing for this webinar. **Please disable the video option when you log in** – video streaming affects the band width and slows down responses during the call.

You shouldn't have any issues with a laptop or smartphone accessing the webinar. If you have an older laptop or a desktop see the information below:

- You can access the webinar via computer (with or without video camera and microphone) or by telephone (cell or landline). You will need audio/speakers to hear the conference – if you can hear music or YouTube on your computer, you should be okay with Zoom.
- If your computer does not have video camera, you will still be able to see and hear the information on your computer screen
- If your computer does not have microphone, you will still be able to see and hear
 the information on your computer screen, you will be able to type your questions
 by chat but can't verbally ask them.

If you have logged in before, I still suggest you log in ahead of the meeting.

Problems accessing via computer: If you have problems logging with your computer the evening of the call you may dial into the call on your cellphone or landline phone.

IMPORTANT – check the provided numbers against your phone plans - you could be charged long distance charges.

Reported Zoom hackers: We had a couple of concerns raised about reports that hackers are accessing Zoom meetings. We have updated the settings in Zoom as per instructions from Zoom and other specialists to stop people from hacking into our call. If you have been advised not to use Zoom for this reason, you may dial into the call on your cellphone or landline phone.

Important points:

When you log into the call you will be put on hold (in a Waiting Room) until the call starts.

All callers will be muted by the system. If you wish to participate or ask a question, click on the 'Raise Hand" button or 'Chat' option - see the document on the website for more instructions.
